The products are intended for pickling of gherkins, mushrooms, vegetables and pickled sausages.

Product

The product PIKANTA® contains spices, mustard seeds, dill, salt and sugar and there is no need to sweeten the pickling brine. The product PIKANTA® HANÁ contains spices and salt. Both products do not contain chemical preservatives and therefore it is necessary to sterilize products in these pickling brines. The product PIKANTA® PIKO contains spices, salt, antioxidant ascorbic acid and preservative benzoic acid and therefore it is intended for pickling vegetables without the sterilization.

The products are made from rock salt mixed with spices and possibly with sugar and chemical preservatives. The products are ideal for pickling of vegetables, mushrooms and pickled sausages.
