

Field of application

MARY — mineral salt is suitable for food preparation and seasoning dishes in households and public catering enterprises where the aim is to limit sodium intake into the body of boarders. With regard to contained potassium chloride it is suitable for people with a combination of diseases, kidney disease and for children under 3 years, to discuss the use of this product with a physician.

Product

MARY – mineral salt is made from food-grade vacuum salt (max.58%), potassium chloride (min. 38%), sugar and anti-caking agents. The product is enriched with iodine. Balanced formula offers a taste comparable to commonly used salt.

The product is made from a pure vacuum salt and potassium chloride. The product is enriched with iodine. It is suitable for the food preparation and seasoning dishes for consumers, who want to limit the intake of salt and therefore sodium into the body. Reduced content of sodium, source of potassium, flowability and iodine are the hallmarks of MARY – mineral salt. The product does not contain allergens and GMO. The recommended daily dose is 5 g. The MARY – mineral salt is not intended for a non salt diet.
